

A GREENER RIDER

It is a fundamental term of this Agreement that the Promoter of the event(s) to which this contract rider applies have considered the environmental impact of this event (these events). Without limitation to the generality of the forgoing we will only perform at event(s) which comply with the following conditions (1-5 inclusive). We reserve the right to withdraw from event(s) without notice and/or cancel any performance without any liability on our part whatsoever where the following conditions are not met.

1. The Promoter must have in place a coherent transport and/or traffic policy which as a *minimum* provides that members of the public are properly made aware of all modes of public transport available to them to attend the event(s). As a minimum a public facing website setting out public transport services must be provided.
2. The Promoter must *wherever reasonably practicable* have a policy for recycling paper and glass and where appropriate plastics and food. The use of disposable plastic containers for either food or drink is not acceptable to us. All and any food and drinks served should be served in either re-usable containers or in paper/card receptacles which can be recycled. All cutlery and utensils provided to the public must be recyclable or bio-degradable.
3. The Promoter must ensure that *wherever reasonably practicable* recycling points must be provided at the venue (venues) and where practicable these should be provided for different waste streams allowing for separate recycling (glass, paper, plastic, foodstuff). All goods left to be recycled must be arranged with a recognised recycling organisation. In the United Kingdom local authorities would be considered a recognised recycling organisation.
4. If you are part of a carbon neutral scheme or similar carbon offsetting scheme this **MUST** be provided by a registered charity or a 'not for profit' organisation. A carbon neutral scheme must *not* be provided by a commercial company or entity or by a 'for profit' organisation. Please notify us at least ten days in advance of the first performance date of any carbon neutral scheme you might be associated with.
5. The Waste of water should be minimised wherever practicable. Promoters must encourage visitors to minimise water wastage. Promoters must ensure caterers, bars and traders use only eco-friendly cleaning products.

OUR ETHICAL POLICY

We try to maintain an ethical stance and there are certain industries (along with companies and organisations servicing those industries) we cannot deal with. We will not deal with those involved in the production, sale or distribution of arms and ammunition. We will not deal with those who are involved in the exploitation of non-sustainable resources in forestry and in the agricultural, mining and fuel industries. We will not deal with those who exploit the individual and/or who do not respect those basic human rights enshrined in the European Convention for Human Rights.

It is a fundamental term of this Agreement that we will **not** appear under any banners, posters, logos or advertising or appear at any event sponsored, endorsed or supported by any company or organisation which does not comply with our Ethical Policy.
